Dear Internet Archive Team,

I am writing to formally request the removal of all archived captures of the following URL from the Internet Archive:

The original publication has been removed by the data controller (Yahoo UK). Despite this, archived copies remain accessible via the Internet Archive and continue to process inaccurate and defamatory personal data.

This processing is unlawful and in violation of the General Data Protection Regulation, including but not limited to:

- Article 5(1)(d) (accuracy)
- Article 16 (right to rectification)
- Article 17 (right to erasure)
- Article 10 (processing of personal data relating to criminal convictions and offences)

The content was unlawful from the outset, and its continued availability through archived snapshots perpetuates ongoing harm. I therefore request the full removal of all archived versions of this URL in

accordance with the GDPR right to erasure and the Internet Archive's own takedown policy.

We additionally request the deletion of any and all archived snapshots concerning this case, in order to prevent the continued availability of inaccurate and unlawful material.

For ease of reference, I invite you to consult the attached document, which is not addressed to you but may assist in providing contextual background. You may also wish to consult the website "therecordspeaks.it" for further relevant information.

I would appreciate written confirmation once the requested removal has been completed.
