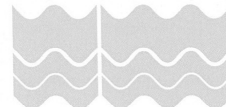

SUMMONS

IN THE HASTINGS MAGISTRATES' COURT

To: Riccardo Gresta

Of: Flat 1, 21 Elms Avenue, Eastbourne, East Sussex BN21 3DN.

INFORMATION has this day been laid before the undersigned by Gareth Jones Solicitor-Advocate (Higher Courts, Criminal) on behalf of East Sussex County Council, that you

1. On or before the 27<sup>th</sup> of April 2022, you dishonestly made a false representation, in a letter dated 19<sup>th</sup> of April 2022 purporting to be from Angus Anderson but in fact written by yourself, that you were unable to walk more than 15-20 metres which is a false statement which you made dishonestly, in order to make a gain for yourself, namely to obtain a Blue Badge which would have provided you with parking concessions, to which you were not entitled, contrary to Section 2 of the Fraud Act 2006.
2. On or before the 27<sup>th</sup> of April 2022, you made an article, namely a letter dated 19<sup>th</sup> of April 2022 purporting to be from a Neurologist called Angus Anderson, when it was in fact written by you, knowing that it was designed for use in connection with a fraud, namely to persuade East Sussex County Council to grant you a Blue Badge to which you were not entitled, contrary to Section 7(1)(a) of the Fraud Act 2006.

YOU ARE THEREFORE SUMMONSED to appear before the Magistrates' Court

At: Hastings Magistrates Court to answer the said Information.
